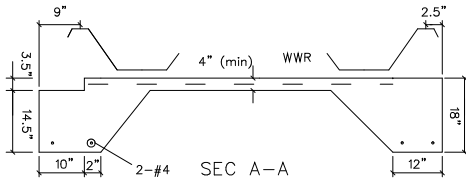
REAR ELEVATION



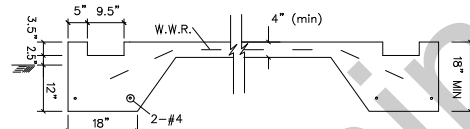
SIDE ELEVATION



FRONT ELEVATION



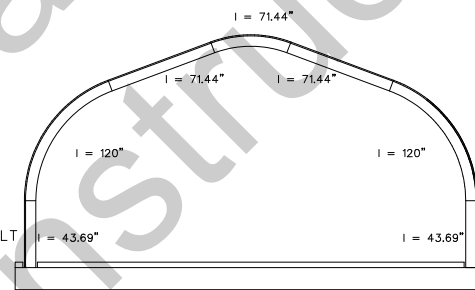

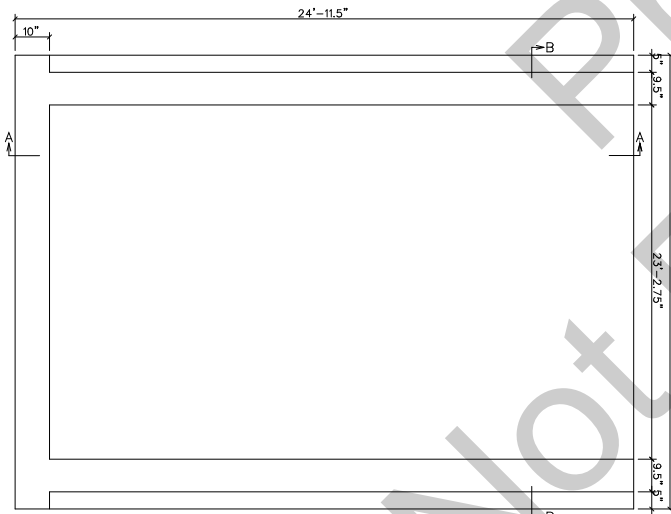

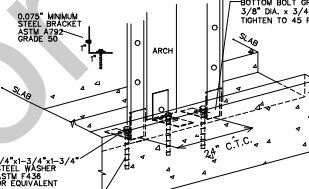


ARCH PROFILE



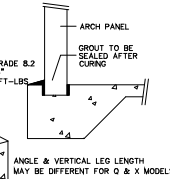
FOUNDATION PLAN

ARCH ANCHORAGE



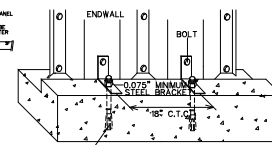
MULTI KH-EZ ANCHORS (CC-ESR-3027) OR EQUIVALENT:

 • OPEN ENDWALL = 11" FROM OPENING + 18" C.T.C.

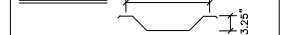

- ALL MATERIAL AND WORKMANSHIP SHALL CONFORM WITH THE REQUIREMENTS OF THE LATEST REVISION OF THE INTERNATIONAL BUILDING CODE 2006. DESIGN ACCORDING TO NASPC-01, NORTH AMERICAN SPECIFICATION FOR THE DESIGN OF COLD-FORMED STEEL STRUCTURAL MEMBERS, AND WITH ANSI/ASCE 7-05.
 - NO LOADS OTHER THAN THOSE GIVEN UNDER "DESIGN DATA" BELOW SHALL BE IMPOSED ON THE "STRUCTURE"
 - SPECIFIC NOTES AND DETAILS SHOWN ON THE DRAWINGS SHALL TAKE PRECEDENCE OVER THE BUILDING MANUAL SUPPLIED.

 - SLAB ON GRADE SHALL BE PLACED ON WELL COMPACTED SOIL CAPABLE OF SUSTAINING 1500 psf WITHOUT APPRECIABLE SETTLEMENT.
